Q4 2016 Highlights

February, 2016

For the fourth quarter of 2016, the SCA Business Services Index increase by 2.99% consistent with an increase of 3.59% for the S&P 500. The Business Services sector, like the overall market, was driven by investors' post-election expectations for accelerating growth under the new administration. In particular, staffing and HR Services, Specialty Consulting and Marketing Services were all trading at near 52-week highs at the end of 2016, as the sectors were poised to benefit from increased hiring and investing from small and mid-sized businesses.

While overall M&A volume in the Business Services sector was down compared to previous quarters, the fourth quarter of 2016 saw a significant increase of new platform acquisitions by private equity firms. Given the recent rise in public market valuations, we expect to see accelerating M&A activity in Q1 2017 as strategic acquirors seek to take advantage of improved valuations before interest rates begin to rise.

Notable merger and acquisition transactions during the quarter included:

- Blackstone Group agreed to acquire Team Health Holdings, Inc. (NYSE:TMH), a provider of physician staffing to hospitals, for \$6.1 billion
- Investcorp Bank B.S.C. (BAX:INVCORP) acquired a majority stake in AlixPartners, LLC, a provider of business and financial advisory services
- Lionbridge Technologies, Inc. (Nasdaq: LIOX), a provider of online marketing and global content management, signed a definitive agreement to be acquired by an affiliate of H.I.G. Capital, LLC
- Odyssey Investment Partners, LLC acquired a majority stake in Addison Group, LLC, a provider of professional staffing services
- White Wolf Capital, LLC acquired NSC Technologies, Inc., a provider of staffing and workforce management solutions for marine, energy, commercial, logistics, and industrial marketplaces






Enterprise Value to NTM EBITDA by SCA Sector




LTM Annual Revenue Growth by SCA Sector

SCA Business Services Universe vs. S&P 500 Total Enterprise Value / Revenue



Net Change in U.S. Employment




SCA Business Services Universe vs. S&P 500 Total Enterprise Value / EBITDA






Sector Stock Performance (one year)




SCA Business Services Universe vs. S&P 500



SCA HR Services Sector vs. S&P 500




SCA Business Process Outsourcing Sector vs. S&P 500




SCA Information Services Sector vs. S&P 500

Notable Industry Developments



Decreases in S&P Information Technology Index

The Standard and Poor's Information Technology Index decreased 0.78% during the fourth quarter of 2016, versus a 12.44% increase in the third quarter of 2016. The Information Technology Index underperformed the S&P 500 index by 2.48% during the fourth quarter of 2016.

Total Nonfarm Payroll Employment Increases by 156,000 in December

Total nonfarm payroll employment, as reported by the Bureau of Labor Statistics, increased by 156,000 in December, a decrease from the past three-month average of 161,000 per month. In December, health care increased by 43,000, social assistance increased by 20,000, food service increased by 30,000, transportation increased by 15,000, financial services increased by 13,000, manufacturing increased by 17,000, and professional and business services rose by 15,000.

Unemployment Rate Changes Little

The Bureau of Labor Statistics reported that job gains occurred in several industries, led by health care, food service, social assistance, manufacturing, transportation, professional and business services, and financial services. Mining, construction, wholesale trade, retail trade, information and government remained unchanged. The unemployment rate was little changed at 4.7% in December, and the number of unemployed persons (7.5 million) changed little.

Fourth Quarter 2016

Employment in Private Sector Increases

According to the ADP National Employment Report, private sector employment increased by 153,000 jobs from November to December. Goods-producing employment decreased by 16,000 jobs in December. Service Providing employment rose by 169,000 jobs in December, down from 228,000 in November. The ADP National Employment Report indicates that trade/transportation/utilities increased by 82,000 jobs in December, while education/health grew by 29,000 jobs. The financial activities industry added 10,000 jobs in December.

Temporary Workers Penetration Rate Remains High

The percentage of temporary workers to total workers, called the "temporary penetration rate," is commonly used as a metric to track the staffing sector. The temporary penetration rate fell 1 point to 2.04% in December, remaining below its all-time high of 2.06% reached in December 2015, according to the Bureau of Labor Statistics. The temporary penetration rate is significant, as small increases in this number have a large impact, amplifying growth as the broader labor market improves.



A new report from the National Federation of Independent Business (NFIB) states that the NFIB Small Business Optimism Index rocketed to its highest level since 2004 with an increase of 38.0 points in December, to 105.8. Expectations for better business conditions accounted for 48% of the overall increase. Sales expectations increased by 20 points and good time to expand increased by 12 points. Inventory increases improved 1 point and capital spending increased 8 points. The percent of owners planning capital outlays in the next 3 to 6 months jumped 5 points to 29%. The average rate paid on short maturity loans declined 10 basis points to 5.5%.
